ATN Programs

ATN currently operates two programs. This role primarily supports the ATN Frontiers program, but also provides oversight for the Designing Your Future (DYF) program.

<u>ATN Frontiers</u> is a professional development program designed to prepare ATN's higher degree by research students for maximum impact in their careers. It is designed to:

- Build practical skills for students apply their research to the workplace.
- Build leadership and future-thinking capabilities.
- Set students up for a successful, high-impact career.

ATN Frontiers promotes the graduation of highly employable researchers who will have developed skills to identify potential disruptors, understand the skills and tools that will help to address, control, and drive these disruptors, and thus be better prepared to fill employment gaps that may not yet exist. The employability skills developed by participation in ATN Frontiers allow graduates to better imagine, understand and effectively shape the future – not simply understand the present.

ATN Frontiers is available free of charge to all higher degree by research students at ATN universities, regardless of academic and professional backgrounds. The program consists of three 'Levels' of online learning modules designed to teach specific skills. The online modules comprise of asynchronous learning components and synchronous live expert-led online sessions. The modules are delivered via a third-party cloud-based learning platform, *OpenLearning*.

The program launched publicly in July 2021, with modules opening to students in late 2021. The program is overseen by the ATN Graduate Deans of Research, who are accountable to the Deputy Vice Chancellors Research and Vice Chancellors. The ATN Frontiers Governance Agreement is the governing document for the program.

ATN Frontiers is managed by the ATN Programs Manager (1.0 FTE) and is supported by the ATN Programs Coordinator (this role, 0.8 FTE).

Position Summary

The ATN Universities Programs Coordinator is critical to the success of the ATN Frontiers program and other ATN education programs – from establishment phase through to maturity, and ongoing business as usual operations. They are responsible for providing high quality administrative, co-ordination, and project support across various program activities, in an end-to-end capacity.

The ATN Programs team is a team of two – the ATN Programs Manager and ATN Programs Coordinator – and sits within the broader ATN Directorate of policy experts and media specialists.

We are seeking a dynamic, creative and experienced program coordinator, with a passion for education and making a positive impact in the sector. The Programs Coordinator will have an understanding of effective and impactful learning experiences, and an interest in contemporary online learning products and practices.

Working directly with the ATN Programs Manager, operational colleagues at our member universities, academic subject matter experts and learning facilitators, the ATN Programs Coordinator will have advanced skills in relationship management, project management, and reporting. They will actively support work to ensure ATN students can participate in ATN programs and implement strategies to maintain their engagement, including community management.

From a day-to-day perspective, the ATN Programs Coordinator will engage with operational colleagues across ATN universities, assist students to enrol, troubleshoot problems, and keep track of enrolment data and student waitlists. They will be responsible for managing student enrolments and assisting teaching staff throughout and between teaching periods. They will also design and activate communication campaigns to build awareness and engagement with ATN Programs.

The ATN Programs Coordinator will be proficient in systems used for project and program coordination, including the Microsoft Office suite, project management tools, and learning management systems. They will monitor processes and take an active role in initiating and implementing improvements.

The role will also support the ATN Programs Manager by managing general correspondence, updating the ATN Programs webpages, organising meetings with key stakeholders, and contributing to planning and running successful virtual and in-person events.

The Programs Coordinator will represent ATN as the student-facing point of contact and will actively help to ensure ATN builds on its already established reputation as a professional and highly effective peak body.

Key Accountabilities

- First point of contact for ATN Programs operational items across our member universities and externally, assisting students by troubleshooting issues, including but not limited to issues related to enrolment and accessing learning management system/s.
- Apply proficient knowledge of academic quality enhancement, policy and compliance, to provide guidance and recommendations for the success of ATN Programs.
- Support the development of quality, policy and compliance initiatives related to ATN Programs. This includes the implementation of effective systems, processes, and reporting that increase the quality and impact of programs and activities.
- Analyse and report on program data and information, including but not limited to student enrolments, student engagement, and other success metrics.
- Responsible for regular reporting of program status and progress through formal report writing for senior university executive audiences.
- Maintain the online presence of ATN Programs, ensuring currency and relevancy for our different audiences.
- Coordinate online professional development sessions, committee meetings and events for key stakeholders.
- Manage correspondence related to ATN Programs, escalating to the ATN Programs Manager where required.
- Assist in the planning and management of ATN events, virtual and in-person.
- Utilise a range of Microsoft Office applications, project management software, creative software for visual data representations, and learning management systems, including the OpenLearning platform used for ATN Frontiers student and learning management
- Undertake other duties within the designated function of the position as directed.

Special requirements:

- This role requires on campus attendance (RMIT City Campus) at a minimum of 2 days a week to support operational requirements.
- Some out of hours work may be required.
- Interstate travel may be required.

Key Selection Criteria

- 1. Experience working within a tertiary education learning and teaching environment, with hands-on experience of actively contributing to a positive, impactful and meaningful student experience.
- 2. Demonstrated communication, relationship building and negotiation skills with the ability to work collegiately with academic and professional staff, and students from diverse backgrounds.
- 3. Excellent written and verbal communication skills with a keen attention to detail and commitment to quality assurance, including the ability to engage with and prepare a range of reports, documentation and communication for a diverse range of stakeholders.
- 4. Demonstrated project management experience, applying principles and practices to achieve project outcomes, ability to prioritise tasks and meet competing deadlines in a high-volume environment, with excellent organisational and time management skills.
- 5. Demonstrated ability to work independently and as an effective member of a team, with the ability to exercise judgment and initiative to achieve excellent outcomes.
- 6. Ability to use initiative to solve problems and undertake decision making relevant to the duties and responsibilities.
- 7. Well-developed skills and demonstrated experience using various digital technologies including the Microsoft Office suite, Adobe, learning management systems, content management systems, and ability to quickly develop skills for using new platforms.

Desirable

- 1. Knowledge of RMIT or other tertiary education environment.
- 2. Experience with OpenLearning online learning platform.
