Recommended for inclusion:

- A variety of original design concepts and outcomes.
- 2D or 3D design, typography, and industry software use such as Adobe CC suite or similar.
- Freehand or digital drawings/illustrations.
- Creative use of design elements like colour, texture, and composition.

Submission instructions:

• Upload your folio as a single PDF (maximum size 10MB). Please ensure to include the page number, and your full name and application number on each page.

 Provide a URL to your folio (please provide the password if applicable). All images must be contained and visible on one webpage.
