Your work should also demonstrate a variety of digital media design outcomes such as:

- o 2D/3D Design
- o Animation
- o UX/UI
- o Games Design
- o Graphic Design
- o Coding

Each sample of work must include a statement describing the project and the outcome. Maximum 100 words per work sample.
